# 2 Policy

#### 2.1 Introduction

#### 2.2 Purpose

### 2.3 Our Approach

This Modern Slavery policy outlines the steps taken by Panoramic Data Limited to address the risks of modern slavery in its operations and supply chains.

This policy indicates the procedures that ensure compliance with the Modern Slavery Act 2015.

### 2.3.1 Ethical Employment Practices

#### 2.3.2 Supplier Code of Conduct

### 2.3.3 Supply Chain Due Diligence

To assess and manage potential risks of modern slavery in our supply chain, PDL engages in the following activities:

- Regularly assessing the risk of modern slavery in our supply chain, prioritizing high-risk areas, and taking appropriate actions to mitigate these risks
- Conducting audits of suppliers to ensure compliance with our ethical standards, including their commitment to eradicating modern slavery

### 2.3.4 Training and Awareness

PDL provides training to employees, especially those involved in procurement and supply chain management, to recognize and address modern slavery risks. This training is regularly updated to reflect latest developments.
